## Life Approvals

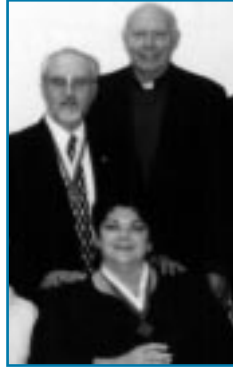
Connecticut, Florida and Georgia have approved the **10 Year Renewable Term (RT10/GD)** brochure featuring the revised life application with new health questions.

## Interest Rate Set

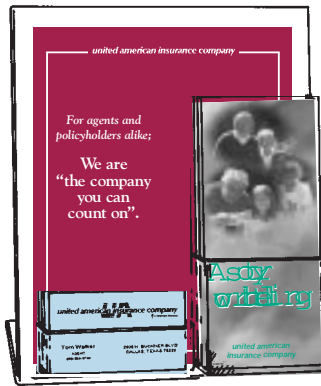
