The Good Sense Plans have issue ages of 0 to 63. Some of the main features of the GSP Standard 15 and GSP Select 25 include a choice of a miscellaneous

hospital benefit which pays up to \$15,000 or \$25,000\*. surgical expense benefit of up to \$5,000 or \$7,500\*, radiotherapy benefit up to \$5,000 or \$7,500\*, and the choice of a daily hospital room benefit of \$100, \$200, \$300
