1. Medicare Supplement issued in **Montana, Minnesota** or **Connecticut** may purchase UA Partners only, NOT ACF Partners.
2. Basic Partners — Prescription, Chiropractic, Vision, Hearing and Dental care.
3. UA Partners — Prior to Jan. 1, 2001, there was a \$3/month charge for basic Partners benefits which included Prescriptions, Chiropractic, Vision, Hearing and Dental care. Effective Jan. 1, 2001 the charge increased to \$5/month adding enhanced benefits of Vitamin and Nutritional Supplements, Travel Discounts, 24 Hour Nurse Line and Emergency Travel Assistance. See handbook for details.
4. Enhanced Partners – Prior to Jan. 1, 2001, there was a \$5/month charge for Partners. Effective Jan. 1, 2001 rates increased to \$6.95/month. This is for basic Partners — Prescriptions, Chiropractic, Vision, Hearing and Dental Care, plus Vitamin and Nutritional Supplements, Travel Discounts, 24 Hour Nurse Line and Emergency Travel Assistance. ACF Partners is enhanced Partners benefits plus “Automatic” Claims Filing[®] for Medicare Supplement policies. See handbook for details.
5. Stand alone Partners — Available to anyone wishing to participate in Partners who does not have or is not purchasing a UA policy. Stand alone Partners can be added to life policies only after issue. Enrollment in the stand alone Partners program can only be initiated by sending in an enrollment form accompanied by the \$36 annual enrollment fee. Enhanced Partners is not available on stand alone Partners.
