In Memoriam

United American mourns the passing of founder and former company president, C.L. "Casey" Dunlap. In 1947, C.L. started UA with his life savings and the help of friends and relatives.

After graduating from the University of Texas, Dunlap practiced law with a prominent firm until WWII. During the war he served as a Naval Aviator and Flight Instructor and was discharged as a Lieutenant, Senior Grade.

When he returned from the war, C.L. opened United American as a one-man, one-room operation in Texas. Today, the company operates in 49 states, D.C., Puerto Rico and Canada. He retired in the early 1980s, but still served on the board of directors for several years. C.L. Dunlap will be greatly missed.
